Pre bid meeting was organized in IRADe office on 27.05.2016 in line with the Addendum 01 - RFP No. SARI/EI-2016-08 issued on 19th May, 2016. Based on the queries received and pre bid meetings discussion, the following amendments and clarifications are hereby issued. **These amendments and clarifications will form an integral part of the RFP.**

Amendment – 01

- 1) The term “software “is replaced by the term “software/ IT tool “at the following places-
 - a. Page no 5 – Bidders requirements – Point A-2
 - b. Page no 7 – Deliverable 2 (a)
 - c. Page no 7 – Point No 3
 - d. Page no 8 – “Bidders may note” – Point No -1
 - e. Page no 15 – “Payment schedule” – Point No -2
- 2) In the note to bidders, starting at page no 8, one additional point is added as point no 8 as mentioned below:-

“The Intellectual property rights of the software/ IT tool developed shall be owned by the bidder. Usage right shall be granted to IRADe for an additional period of one year after the completion of the assignment.”

Clarification-02

Based on the queries received and pre bid meeting discussion, the following -clarifications are being issued:


S.No.	Query	Clarification
1.	The applicable time period of this project is mentioned as 1st Apr’15 to 31st Mar’16. What will be the applicable time period for this project now?	This is correct. The project will be executed using the past period data as mentioned in the Scope of Work.
2.	Whether a consortium is allowed to participate in the said opportunity?	Yes, however IRADe will interact with a lead consortium partner regarding all the deliverables and payments. Lead consortium partner should provide copy of signed MoU as a part of the bid document.
3.	Whether block bids shall be allowed in the mock exercise.	All bids shall be single bids. No block bids shall be allowed. However, differential bids shall be allowed.

4.	Whether IRADe will be providing any space for the developmental activities of this project?	No
5.	Whether all the capacity building and training programs for the participants will be held in New Delhi alone or some other place?	Yes. Stakeholder consultation will take place in the respective countries as per Scope of Work..
6.	Whether the consultant is supposed to arrange the logistics for the participants from participating countries or it will be taken care by the participants themselves?	This is mentioned in the Annexure-1 "Scope of work." Please refer to page 8 , Point No - 4
7.	In case of activity 5, regarding consultation with stakeholders, whether the consultant is required to travel to the participating countries or the meetings can be convened on video/ audio conference?	Consultant is required to travel to the participating countries. Video/audio conference shall be in addition to the same if required.
8.	Clarification on the location of running the pilot market?	The bidder may like to run the same at their own premise
9.	Who shall host the software, who shall provide necessary Server/ Workstation for installation of server, infrastructure required and who will be responsible for procuring the necessary system/ database licenses?	The bidder is to arrange for these as mentioned in the Scope of Work also. The core team is expected to have laptops of their own for this project.
10.	In one particular deliverable, extra time has been requested by one of the bidders. Similarly changes in payment schedule has been requested by one of the bidders. Details regarding the breakup of marks in various items related to technical proposal has been requested by one bidder.	No extension/ changes envisaged as discussed in the pre- bid meeting. The break up will be same for all bidders. However, the actual marks for various items shall be based on our internal policies and the same is not disclosed
